**Release and Waiver of Liability**  
Assumption of Risk and Indemnity

Read this agreement carefully before signing it. Your signature indicates that you understand and agree to the following terms. By signing this agreement, you and your child(ren) are giving up legal rights, including the right to sue or recover damages in case of injury, death, or property damages for any reason, including but not limited to the negligence of this stable, its owners, employees, agents, and clients ("the RELEASEES").

In consideration for allowing me (or my minor child) to handle/ride a horse, I on behalf of myself, my child, or our personal representatives, heirs, next off kin, spouses and assignees, I HEREBY:

1. Acknowledge that an equine may, without any warning or apparent cause, make unpredictable movements; ie buck, stumble, fall, rear, bite, kick, run, spook, jump, step on a person's foot, push or show. Saddles/bridles/harnesses/equipment may loosen or break... all of which may cause the rider/handler to be jolted or fall, resulting in serious injury or death.
2. Acknowledge that horseback riding/handling is an inherently dangerous activity and involves risk that may cause serious injury and in some cases death. Because of the unpredictable nature and irrational behavior of horses, this risk is assumed REGARDLESS of past training or performance.
3. Release, discharge, and promise not to sue the STABLE doing business under its own name or any other name and/or any of its RELEASEES, for any loss, damages, or cost whatsoever, associated with my person or personal property.
4. Release the RELEASEES from any claim that such RELEASEES are or may be negligent in connection with my riding experience or ability, in connection with riding, training, or handling of horses, maintenance and their respective equipment.
5. The undersigned expressly agrees that this foregoing release, waiver of liability, assumption of risk, and indemnity agreement is governed by the STATE OF ARIZONA and is intended to be as broad and inclusive as is permitted by Arizona State Law, and that in the event any portion of the Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the Agreement as a whole shall not be affected or impaired in any way, and shall continue to hold full legal force.
6. Acknowledge that this document is a CONTRACT, and agree that if any lawsuit is filed against the STABLE or its RELEASEES for any injury or damage in breach of this contract, the Undersigned will pay all attorney costs incurred by the STABLE in defending such action.
7. State that I have no medical conditions that would be affected or worsened by horseback riding, including but not limited to pregnancy, epileptic seizures, heart condition, head/neck/back injury, etc. (Please initial here) \_\_\_\_\_
